I am pleased to advise that I have approved the following amendments concerning the Town of Stratford Official Plan and Zoning and Development Bylaw as follows:

Official Plan - Map Amendment

A portion of parcel #518910, #398610, #538132 and #482307 (approximately 1.3 acres) located on Dale Drive to be designated as Mixed Use on the Town of Stratford Official Plan Land Use Map excluding the former designation of Commercial.

Zoning and Development Bylaw – Map Amendment

A portion of parcel #518910, #398610, #538132 and #482307 (approximately 1.3 acres) located on Dale Drive to be designated as Mason Road mixed Use (MRMU) in Schedule "A" of the Zoning Map of the Town of Stratford Zoning and Development Bylaw #45, excluding the former designation of Commercial.





Bylaw # 45-A

A Bylaw to amend the Town of Stratford Zoning and Development Bylaw, Bylaw #45 to change Schedule "A" Zoning Map

BE IT ENACTED that a portion of parcel numbers 518910, 398610, 538132, 482307, (approx. 1.3 acres) be hereby designated as Mason Road Mixed Use (MRMU) in Schedule "A" of the Zoning Map of the Town of Stratford Zoning and Development Bylaw #45, as shown on the attached map, hereby excluding it from its former designation of Mason Road Commercial (MRC).
