BUILDING BYLAW AMENDMENT

BYLAW NUMBER 50-A

A Bylaw to amend the Building Bylaw, Bylaw # 50-A, General Amendments.

This bylaw is made under the authority of the *Municipal Government Act, R.S.P.E.I. 1988, Cap M-12.1 as amended from time to time and the Building Codes Act, R.S.P.E.I. 1988, Cap. B-5.1 as amended from time to time.*

BE IT ENACTED by the Council of the Town of Stratford that the Building Bylaw, Bylaw #50, be amended as follows:

1. Section 4.23 is amended by add the words “for Buildings” after the words “National Energy Code of Canada” and before the word “adopted”.
2. Schedule A, A.1.2 is amended by deleting the date “2015” and replacing it with the date “2017”.
3. Section 20.9 is amended by adding the words “or withdraw” after the word “withhold” and before the word “all”.

The 1st reading of this bylaw was approved by Council at a meeting held on April 8th, 2020.

The 2nd reading of this bylaw was approved by Council at a meeting held on May 13th, 2020.
