BE IT FURTHER RESOLVED that:

- the non-commercial municipal tax rate be set at \$0.45 per \$100 of assessment for 2021.
- the non-commercial non-resident municipal tax rate be set at \$0.90 per \$100 of assessment for 2021.
- the non-commercial apartment municipal tax rate be set at \$0.66 per \$100 of assessment for 2021.
- the non-commercial non-resident apartment municipal tax rate be set at \$1.32 per \$100 of assessment for 2021.
- the non-commercial motel municipal tax rate be set at \$0.66 per \$100 of assessment for 2021.
- the non-commercial non-resident motel municipal tax rate be set at \$1.32 per \$100 of assessment for 2021.
- the commercial municipal tax rate be set at \$1.25 per \$100 of assessment for 2021.

This resolution bears the recommendation of the Finance Committee as discussed at a meeting held on March 16, 2021.
