The machine offered under this proposal shall be widely offered for sale, and equipment other than new or current year models will not be considered responsive to these specifications. Accessories and Attachments available but not included in the tendered price, should be priced individually in the table included with this package. Accessories and Attachments included in the tender submission must be calculated into the tendered price.

The bidder must be a manufacturer, a factory branch, or an agent engaged in the business of selling and servicing the equipment bid upon and must maintain a full stock of parts and provide full service. Parts must be available within two (2) days of receipt of order.

Proposals shall be considered on units other than North American manufacture, providing service and parts are available.
