***WHEREAS*** an application has been received from Andrew and Jennifer McCalla to rezone parcel number 289652 (1.16 acres) from the Agricultural Reserve Zone (A1) to the Single-Family Residential Zone (R1); and

***WHEREAS*** the applicants are also applying to change the Land Use Designation of parcel number 289652 (1.16 acres) from Agriculture to Residential; and

***WHEREAS*** a public meeting was held on July 22, 2009 to solicit input from residents within 150m (500 feet) of the subject property in which we had two residents attend and one formal letter was received stating they had no objection to the current request;

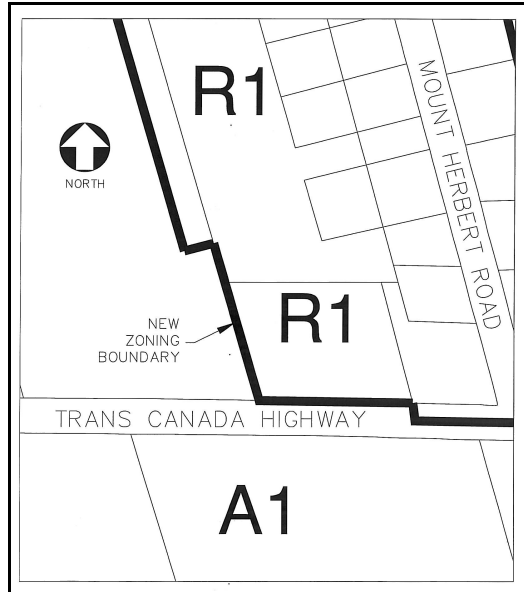
***BE IT RESOLVED*** that Town of Stratford Official Plan - General Land Use Map be amended to change the designation from Agricultural Reserve Zone (A1) to Residential (Serviced); and

***BE IT FURTHER RESOLVED*** that Zoning Amendment #29 - **A003-2009** a bylaw to amend the Town of Stratford Zoning and Subdivision Control (Development) Bylaw #29, and the Town of Stratford Revised Official Plan (2003) be hereby read and approved a second time.

**A BYLAW TO AMEND THE TOWN OF STRATFORD REVISED OFFICIAL PLAN  
(2003) AND THE TOWN OF STRATFORD ZONING  
AND SUBDIVISION CONTROL (DEVELOPMENT) BYLAW #29**

The Council of the Town of Stratford under authority vested in it by Section 18 and

8 hereby enacts as follows:



The designation of parcel number 289710 (1.16 acres)) as shown on the map, is hereby designated as Residential in the Town of Stratford Revised Official Plan 2003, hereby excluding it from its former designation of Agricultural and shall also be designated as a Single Family Residential (R1) in Schedule “A” of the Town of Stratford Zoning and Subdivision (Development) Bylaw #29, hereby excluding it from its former designation Agricultural Reserve Zone (A1)
